Introduction

Our firm, Pallas Capital Advisors LLC, is registered as an investment adviser with the U.S. Securities and Exchange Commission. Brokerage and investment advisory services and fees differ and it is important for you to understand these differences. Free and simple tools are available to research firms and financial professionals at Investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing.

Relationships and Services

What investment services and advice can you provide me?

Services: We offer investment advisory services to retail investors. These services include wealth management, which is a combination of investment management and comprehensive financial planning. We also offer family office services to our clients. Our services are typically offered as a wrap fee program where we combine securities transaction fees and other fees and expenses with our investment advisory services. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to develop an investment approach.

Accounts, Investments, and Monitoring: We provide services to individual, joint, retirement, trust and estate accounts. We primarily use individual stocks, individual bonds, exchange-traded funds, mutual funds and independent managers in constructing portfolios. We provide investment supervision, including monitor portfolios and securities in accounts on a regular and continuous basis. We also meet with you at least annually, or more frequently, depending on your needs.

Investment Authority: We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing.

Account Minimums & Other Requirements: We do not require an account or relationship size minimum in order for you to open/maintain an account or establish a relationship.

Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?

Asset-Based Fees: Our asset-based fees for wealth management services range from 0.25% to 2.00% annually. Additionally, at our discretion, we may decide to pass on the fees associated with the use of third party portfolio management platforms. Such fees range up to 0.04% annually. These fees are collected on a quarterly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will pay more in advisory fees. If you are engaged in our wrap fee program, asset-based fees will include most securities transaction fees and fees to a broker-dealer or bank that has custody of your assets.

Hourly Fees: Our hourly fees for financial planning services range from \$300 to \$500 per hour. Hourly fees may be invoiced up to 100% of the expected total fee upon execution of the financial planning agreement. With the balance, if applicable, invoiced and due upon completion of the agreed upon deliverable[s]. Hourly fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We provide you with an estimate for total hours and overall costs prior to engaging us for these services. We complete financial planning engagements in six (6) months or less. We will not collect an advance fee of \$1,200 or more for services that will not be completed in under six (6) months.

Fixed Fees: Fixed fee engagements for financial planning services typically range from \$1,500 to \$20,000. Fixed fees for financial planning engagements may be invoiced up to 100% of the expected total fee upon execution of the financial planning agreement, with the balance invoice, if applicable, upon completion of the agreed upon deliverable[s]. Fixed fees for family office services typically range from \$5,000 to \$30,000 per year. This fee is collected on a guarterly basis. Fixed fees are

negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We provide you with an estimate of the total cost prior to engaging us for these services.

Other Fees & Costs: If you are in our wrap fee program, applicable securities transaction and other custodial fees will be included in our advisory fees. You will be responsible for any third-party manager and/or platform fees, account administrative fees, fees and expenses related to mutual funds and exchange-traded funds and applicable securities transaction fees.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.

Some of our financial professionals are Registered Representatives with a broker-dealer. In addition to our services, your financial professional will offer you brokerage services through their separate capacity as a Registered Representative and will earn commission-based compensation for transactions implemented through a broker-dealer. The commissions earned are separate from our advisory fees, which creates a financial incentive to recommend that you implement securities transactions through a broker-dealer.

How do your financial professionals make money?

Our financial professionals are compensated based on the revenue generated from advisory services, which is distributed in accordance with our partnership agreement. This means our financial professionals have an incentive to increase the asset size in the relationship or solicit new business, taking time away from the day-to-day servicing of existing clients.
